Dear Texas State Board of Education,

My name is Rachana Chhin. I am the Legislative Counsel for the Texas Catholic Conference of Bishops, the public policy voice of the Roman Catholic Church in Texas. I respectfully request to change my testimony from commenting on to testifying against the proposed SBOE K-12 TEKS curriculum.

First, we do not believe that the SBOE should pass these TEKS standards because doing so violates the intent of TEC 28.004 that requires consideration of "local community values" and the consideration of "recommendations of the local school health advisory council" before changing the district's "health education curriculum or instruction." If the SBOE does adopt TEKS that include these new standards, they must also change Texas Administrative Code Chapter 74.1 (b-6) to allow school district discretion to omit or delete TEKS.

Second, we believe parents are the primary educators of their children and this right and responsibility must be respected in any sexuality education that is presented. While schools are called to carry out an important mission in education, we believe they do not substitute the role of parents but, rather, complement it. Thus, we would prefer that all parents be provided access to the curriculum in advance and be given the opportunity to opt-in rather than opt-out.

Third, we insist that sex education must consider the totality of the person, including the physiological and psychological specificity of young people, their neurocognitive growth and maturity, and accompany this development in a healthy and responsible way. Therefore, we express concerns that the TEKs do not adequately prohibit graphic depictions of sexual activity or prevent teachers and school districts from adding inappropriate content.

Finally, while we do not support these new health TEKS being passed, we are grateful that the SBOE reinforced abstinence as the only 100% method to avoid risks and for rejecting harmful and inappropriate suggestions that encourage abortion access as a right or that would promote gender ideology. Thank you.
